Filling out a Complaint Form Instructions and Process of Filing a Complaint*

- 1. Plaintiff: Insert your name and Tribal ID# (if applicable)
- 2. Defendant: Name of person or Tribal Department.
- 3. **Complaint**: In this section state the nature of your complaint and who and what caused it. Be specific as possible regarding what happened.
 - **a.** Basis of Tribal Court Jurisdiction in regards to violation attach Constitution or Ordinance.
 - **b.** If you know of any <u>Tribal Law</u> that was violated as part of your above statement, state what it is. If not, leave it blank. The Tribal Court Clerk cannot help you with section as the Tribal Court Clerk is not able to give Legal advice. The Tribal Court Clerk can help with explaining the process only.
 - c. Please explain the relief you are seeking. If you are suing the Tribe, be aware that the Tribe has Sovereign Immunity.
- 4. You must swear that everything you have stated in the complaint is true. You can be charged with perjury if you intentionally state in the complaint anything that is not true. Print and Sign your Legal Name with date and address with phone number.
- 5. Once Complaint Form is filled out properly a \$40.00 court filing fee is required to be filed with the complaint. Court only accepts Cash, Money Order or Cashier's Check.
- 6. Once you have filed the Complaint and paid the Filing Fee with the Court, the Court Clerk will issue you a Summons and Affidavit of Service. You must serve the Complaint to the Defendant with a Summons and copy of the Complaint. Once you have served the Defendant by mail or hand deliver an Affidavit of Service (which is the complaint's proof of delivery) needs to be bought to the Court Clerk.
