## Chairman's Column



Dear Tribal Community,

We have had a busy month and continue to move forward! We had a record turnout of voters at our February election: more than any other non-officer election so far. Over 500 tribal members came out to vote! Our community has spoken and voted to keep the incumbent Tribal Council members in their seats. Congratulations to Council Members Carlton Hendricks, Cheryl-Frye Cromwell, Yvonne Avant and Winnie Johnson-Graham! Great job to everyone who ran for a seat this election and a special thanks to our Election Committee for all their hard work! As voted on by Tribal members and Tribal Council, this election was for a one-year term so these seats will be up again next year.

Another accomplishment this month was the Tribal-State Compact becoming official. The Compact becomes official when the Interior Department posts it in the Federal register and it becomes federal law. The Compact is effectively a license for our Tribe to provide Class III gaming at the gaming site in Taunton, Massachusetts, after Land Into Trust is completed by the U.S. Department of Interior. If the Massachusetts Gaming Commission breaches the Tribal-State Compact in region C, awarding a Commercial license to another destination resort Casino, our Tribe will pay zero revenue to the Commonwealth of Massachusetts. If the Mass Gaming Commission does not award another Commercial Destination Resort Casino license in Region C, our Tribe will pay 17 percent gross gaming revenue to the Commonwealth. This

## All Four Incumbents Re Elected

The Tribal Council remains the same, as voters re elected all of the incumbents at the February 9 elections. 513 Tribal Members made it out to the polls. Carlton Hendricks Jr., led all candidates with 246 votes followed by Cheryl Frye Cromwell with 225. Yvonne Avant received 215 votes and Winnie Johnson Graham got 213 votes.

The 513 voters set a record for turnout at an election that did not include one of the four officer positions on the Tribal Council.

"I am proud of our tribal members for turning out in such numbers to exercise their right to vote and affirm the sovereignty of our nation," said Chairman Cedric

## Progress with Project First Light

**T**he Mashpee Wampanoag Tribe announced on February 11 that the public comment period on the Tribe's land into trust request, which includes lands in Mashpee and the Project First Light destination resort casino in Taunton, is now over and the final phase of the environmental review process is now underway.

"We appreciate all the feedback from residents in Southeastern Massachusetts during the public comment period on our Project First Light environmental impact reports." Mashpee Wampanoag Tribal Chairman Cedric Cromwell said today. "With the comment period for federal and state reviews now over, we are pleased to start the final phase of the environmental impact review process. The BIA and the Tribe are now examining all public comment and preparing the final environmental impact reports, which will be available for public review and comment soon."

While Project First Light has benefited from significant local support, the Tribe is focusing on some of the specific concerns expressed by local residents during the comment period. A number of public comments concerned the current traffic congestion in and around the Route 24 and 140 interchange. The Massachusetts Department of Transportation has already targeted the interchange as a priority and unveiled its own proposals to improve the interchange over a year ago. The Tribe and the BIA outlined their own recommendations in the Draft Environmental Impact Report and Draft Environmental Impact Statement published last year, and are looking forward to continuing to work with all stakeholders to complete the review process.

The Tribal gaming compact with the Commonwealth of Massachusetts includes important funding and mitigation provisions. Once the Project First Light destination resort casino is operating and generating revenue, the Commonwealth is expected to receive \$2.1 billion over a 20 year period. The tribe's funding will be directed to address a variety of purposes, including education, transportation, infrastructure and tourism programs. There is also \$300 million that is specifically allocated for Southeastern Massachusetts.

The compact also has provisions that reduce these revenue commitments if another casino or slot parlor license is issued in Region C. Should another casino be licensed in Region C, then the tribe would not be obligated to provide \$2.1 billion in funding. Its financial obligations would be reduced to zero. A slot parlor license in Region C is estimated to reduce the tribe's financial commitment to the Commonwealth by roughly \$300 million.



"We are very pleased with the support from the Governor, the Commonwealth's legislative leadership and Taunton's civic and business leaders, especially Mayor Hoye." Cromwell said today. "I also want to commend the Obama administration for making land acquisition a priority for Native Americans. The administration is making significant progress in reaching its goal of placing 500,000 acres of land in trust by December 2016. Already the Bureau of Indian Affairs has processed more than 1,400 individual trust applications, accepting more than 230,000 acres in trust on behalf of tribes."

## Health Insurance Deadline March 31

**M**ake sure you are enrolled in a health insurance plan through the Marketplace by March 31, 2014. Everyone is required to have health insurance coverage in 2014, or pay a fee when they file their federal income tax return in 2015. The fee is sometimes called the "shared responsibility payment." After open enrollment ends on March 31, 2014, health coverage is no longer available through the Marketplace until the next annual enrollment period, unless they have a qualifying life event. For more information visit [www.healthcare.gov](http://www.healthcare.gov).

There is an application for exemption for American Indians. Enrolled Tribal members interested in an exemption from the Shared Responsibility Payment must apply for an exemption through the Marketplace, or on their 2014 taxes by April 2015. The exemption certificate number is issued to Tribal individuals for life, and since you never know when you might have a gap in health insurance, Tribal members should apply for the exemption regardless of whether they choose to carry health insurance. Applications for exemption are available at Tribal Health office.

## Commonwealth Care is Ending

If you pay a monthly Commonwealth Care fee, then you will need to reapply for new health insurance by March 24, 2014 to avoid gaps in your coverage. You will most likely qualify for a new program called ConnectorCare. Applications are available at the Tribal Health office or visit [www.mahealthconnector.org](http://www.mahealthconnector.org).

## Tribe Commemorates Relationship with Harvard

Chairman Cromwell gathered at the Harvard Faculty Club with Tobias Vanderhoop, Chairman of the Wampanoag Tribe of Gay Head Aquinnah, and others on February 7<sup>th</sup> for a clambake in honor of the tribe's long-standing relations with the university.

"The Mashpee Wampanoag tribe and Harvard University have ties that go all the way back to the university's earliest days," Chairman Cromwell said. "It's important to celebrate that connection and look for ways that we can work together in the future."

He told the Harvard Crimson, the university's student newspaper, that Harvard should try to do more to include Native American tribes.

The Charter of 1650, the document that establishes the Harvard Corporation as the governing body of the university, mentions Native American students, stating that the nascent college should serve both "English and Indian youth."

Cromwell has organized efforts to

integrate Harvard with the Native American community by lobbying the College to award Joel Iacoomes with a posthumous degree in 2011. Iacoomes was a Wampanoag tribal member and Harvard attendee, who died in a 1665 shipwreck shortly before graduating,

Chairman Cromwell told the

Crimson that Harvard must continue to foster relations with local tribes — particularly by recruiting more indigenous students.

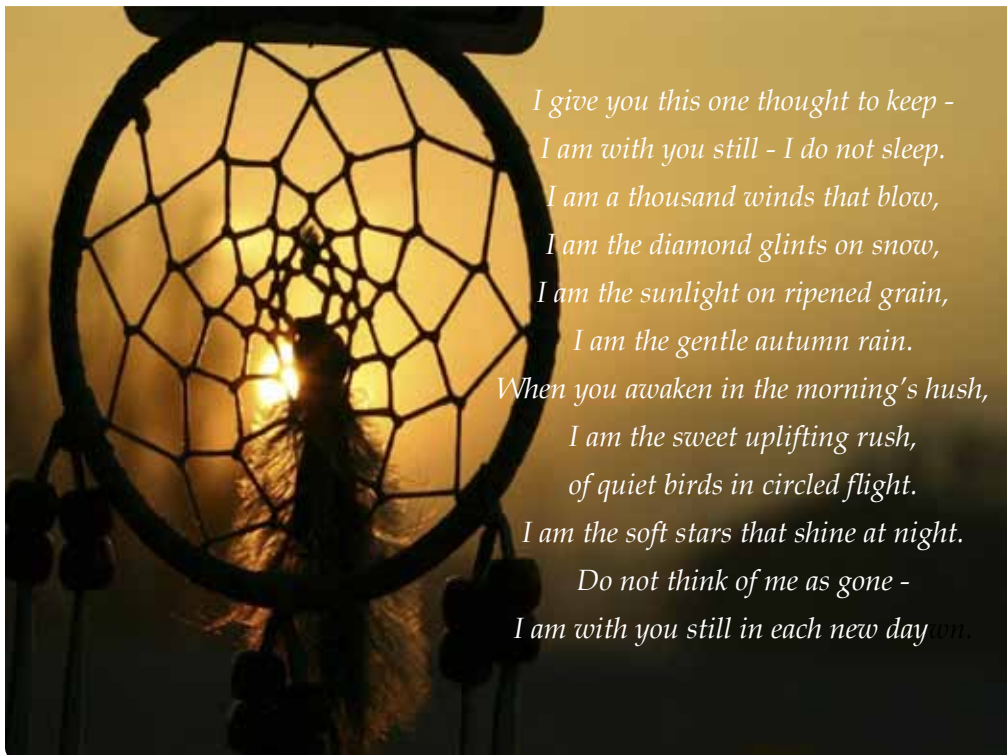

## Quit Commercial Tobacco NOW

**T**he Mashpee Wampanoag Health Service Unit would like to help anyone with his or her efforts to quit commercial tobacco and urge anyone who regularly uses commercial tobacco to consider all risks associated with it.

- ✓ Tobacco use is responsible for more than 430,000 deaths each year and is the largest cause of preventable death and disease in the United States
- ✓ 32.4% of Native American people smoke. This is the highest smoking rate for any ethnic or racial group in the United States

Traditional tobacco is different because tobacco is a sacred plant that has been used by Native Americans for thousands of years for religious, ceremonial, and medicinal purposes. Sacred or traditional tobacco is different from commercial tobacco. Commercial tobacco contains many added chemicals that are harmful to our health.

Benefits of quitting commercial

tobacco include:

- ✓ More money in your pocket from not buying commercial tobacco products
- ✓ Be a positive role model for your loved ones
- ✓ Not exposing yourself and others to secondary smoke
- ✓ Fresh breath instead of tobacco breath

If you are currently using tobacco products, there are many health benefits of quitting. If you are a smoker, quitting will reduce your chance of having:

- ✓ Cancer of the lungs, throat, mouth, lips, gums, bladder and kidney
- ✓ Heart disease, hardening of the arteries, and stroke
- ✓ Emphysema and other lung diseases
- ✓ Circulation problems

If you have children, your quitting can lower their risk of:

- ✓ Sudden Infant Death Syndrome (SIDS)
- ✓ Asthma
- ✓ Ear infections

- ✓ Allergies
- ✓ Bronchitis and other lung problems

#### Danna Jackson Role Model Scholarship \*self-nomination

Within our tribe we have many youth that other youth can look up to and that is exactly what this scholarship honors. This award shall be presented to one tribal member either a junior or senior in high school that has worked hard to advocate for the Mashpee Wampanoag tribal youth as well as give them someone young to look up to. This year the recipient of this award shall receive a \$500 scholarship towards school to honor their devotion to the Mashpee Wampanoag Youth. Please submit a personal essay on why you believe you should receive the scholarship.

#### Tribal Youth Leadership Award

This award honors two Mashpee Wampanoag Tribal Youth (one female and one male) from the age of 13 to 19. These youth should display traditional values, good grades, a strong work ethic, respect and all other leadership qualities.

#### Youth Leadership Award

This award will be given to non-tribal members from the ages of 13 to 19. The

recipients of this award should display academic achievement, community service, strong work ethic as well as all other leadership qualities. (Recipients may be non-tribe or from another tribe).

#### Dream Big Award

This award honors two Mashpee Wampanoag Tribal Youth (one female and one male) from the age of 13 to 19. This award is given to two tribal members who do not have any limitations to what they believe they can achieve. It is given to two youth that know what they want to accomplish and are willing to work and persevere through any odds to succeed. These people should be positive and optimistic while believing and having faith in themselves as they take steps to reach their dreams.

#### Sportsmanship Award

This award honors two Mashpee Wampanoag Tribal Youth (one female and one male) from the age of 13 to 19. The recipients of this award should demonstrate devotion to a sport and team as well as being a valued player because of their skills and positive influence on their teammates.
